The Fund's goal is long-term capital appreciation and current income with a greater emphasis on long-term capital appreciation. The Fund pursues its investment objective by investing in other mutual funds ("Underlying SA Funds") managed by Focus Partners Advisor Solutions comprising various asset categories and strategies. Focus Partners Advisor Solutions has established an asset allocation target for the Fund. This target is the approximate percentage of the Fund's assets that will be invested in equity investments and fixed income investments. Under normal market conditions, the Fund currently expects to invest approximately 70% of its assets in equity investments and approximately 30% of its assets in fixed income investments as represented by the holdings of the Underlying SA Funds in which the Fund invests. Actual allocations to fixed income investments or equity investments can deviate by up to 10%. For a complete description of the Fund Objective, refer to the fund prospectus.

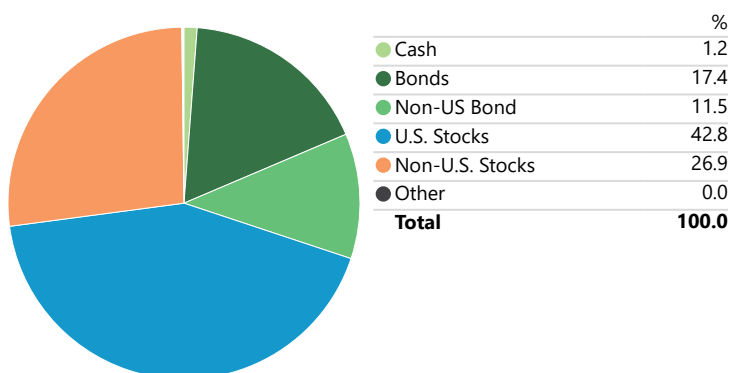

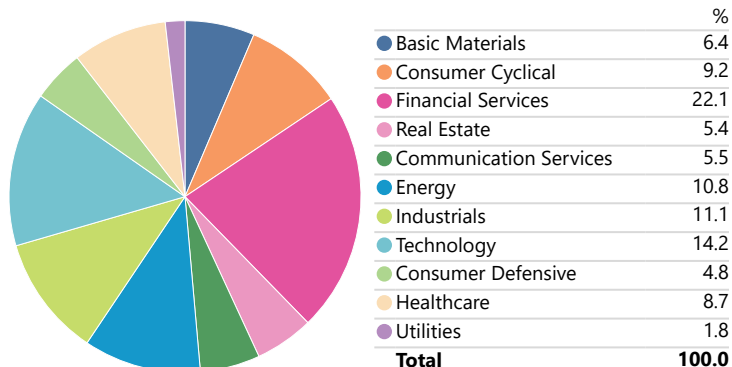

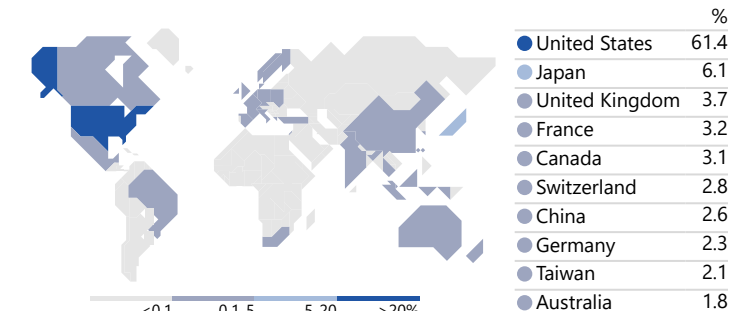
