This agreement to waive fees and/or reimburse operating expenses with respect to the SA US Fixed Income, SA Emerging Markets Value and SA Real Estate Securities will remain in effect until October 28, 2028, at which time it may be continued, modified or eliminated and net expenses will be adjusted as necessary.
